1) Call to Order

The meeting was called to order by President, Sloan Clack at 6:07 p.m.

- 2) 20-Minute Homeowner Open Forum No Comments One homeowner in attendance
- 3) Review and Approval of April 21, 2010 Board Meeting Minutes

Motion: Minutes approved as presented on a Tony Sims/Eric Corliss M/S/C by unanimous vote.

4) President's Report

- a) Update on Southpoint Water Connection. TGM to complete install by June 11th. Rain and Shady to install sprinkler heads. Corliss Resources to provide 55 yards of topsoil.
- b) Letters have been sent to Deer Ridge and Savannah Ridge residents encroaching on SMA common area property. Sloan is working with attorney on this issue.
- c) K-Com is trenching and laying fiber optics in Deer Ridge common area along 122<sup>nd</sup>. Water is now coming up from the ground. TGM does not believe that it is an irrigation issue. K-Com did not call before they dug. Tacoma Water will be called to do a site visit soon. The SMA will be sending a letter to K-Com putting them on notice.
- d) After TGM tried to restart the irrigation system this spring, it was evident that the system was not blown out properly by Rain & Shady Landscapes. Rain & Shady is currently working with TGM to resolve the issue at their expense.

- b) Adjustment to Benum accounts write off presented by Angie. \$1,517.60 less money was written off than originally presented due to one of the parcels being sold and the lien being paid off through David Tall's office.

1) 122<sup>nd</sup> Deer Ridge Trees

*Motion:* The Board of Directors, with the help of the Budgeting Committee, will revisit and evaluate the Landscaping Plan in conjunction with the Budgeting process this fall. Tony Sims/Sloan Clack M/S/C by unanimous vote.

2) Resurface tennis court and basketball court in accordance with Reserve Study. Angie to send notice to community members that courts will not be usable for about ten days through e-Blast.

*Motion:* The Board of Directors approved TGM landscaping bid and Pacific Ace, LLC resurfacing and repair bid for a total of \$22,910 including sales tax to do the following: tennis court repair and resurface, landscaping improvements and removal of trees/roots, and basketball court resurfacing. Tony Sims/Sloan Clack M/S/C by unanimous vote.
